4. Collection and processing of personal data and the nature and purpose of their use

4.1 Scope of processing

We process your personal data for the following purposes:

a) Contacting and interaction

We process your personal data when you contact us via XING. When contacting us via XING, we can see the data you provide and your XING profile. When interacting with you via our XING company profile, the following data is processed:

- Date and time of interaction
- Type and content of the interaction (e.g. direct messages, comments)
- Profile name
- Profile picture

We collect your personal data to respond to your contact and interaction request, to publish current job advertisements and to report on current topics of innovative vehicle design. XING itself uses the data to create analyses / evaluations / statistics.

The legal basis of the processing is Art. 6 para. 1 f) GDPR. The legitimate interest we pursue lies in the communication with you. In addition, our XING company profile is intended to enable you to contact us quickly and easily, as well as to inform you about current topics in innovative vehicle design.

If you contact us via XING for the purpose of concluding a contract with us, Art. 6 para. 1 b) GDPR is the legal basis for the processing.

b) Evaluation for statistical purposes by means of page insights by XING

We use XING Insights on our XING profile for the purpose of demand-oriented design and continuous optimization of our offer and to display target group-oriented posts. In the form of statistics, we receive anonymized information from XING about how many users visit the page and how they interact on our profile (page insights). The categories of personal data processed in this way include for example age, gender, city, language and if applicable, further data provided by you.



To this extent, the processing is carried out under Joint responsibility with XING in accordance with Art. 26 GDPR. We will provide you with the essential of the Joint-Controller-Agreement upon request.

We process the data with the help of page insights for the purpose of optimizing our offer and ensuring more effective communication with interested parties.

The legal basis for the processing is Art. 6 para. 1 f) GDPR. The legitimate interest pursued by us lies in an improvement of our offer on XING.

4.2. Recipients

Within our company, only those departments and employees working there who absolutely need such access to fulfill their functions or tasks have access to your personal data.

We will only share your personal data with external recipients if there is a legal justification for this or you have consented to it. External recipients may be:

- Processors: service providers we use to provide services or who are entrusted with the maintenance of our IT systems.
- Public bodies: Authorities and government institutions, such as courts or tax authorities, to which we may need to transfer personal data in individual cases.

4.3 Data transmission to third countries

As a matter of principle, we only process your personal data in Germany and in the European Union. Regarding third country transfers by XING, we refer to their privacy notice: https://privacy.xing.com/en/privacy-policy.

4.4 Deletion of personal data

In any case, we store your personal data only as long as this is necessary for the fulfilment of the purposes described above. In the event of an objection, we will delete your personal data unless their further processing is permitted under the relevant legal provisions. In addition, illegal content will be deleted.

4.5 Data subject rights

If your personal data is processed, you are a data subject within the meaning of the GDPR and you have the following rights against the controller:

Access: You have the right to obtain information about the personal data processed about you.

<u>Rectification:</u> You can request the rectification of incorrect data concerning your person. In addition, you can request the completion of incomplete data.

<u>Erasure:</u> In certain cases, you can request the deletion of your personal data.

<u>Restriction of processing:</u> In certain cases, you can request that the processing of your data be restricted.

<u>Data portability:</u> If you have provided data based on a contract or consent, you can request that you receive the data you have provided in a structured, common and machine-readable format or that it be transferred to another controller.

<u>Withdrawal of consent:</u> If you have given your consent to the processing of your data, you can withdraw this consent at any time with effect for the future. The lawfulness of the processing of your data until the withdrawal remains unaffected.

Right to object

You have the right to object at any time to the processing of your personal data based on Art. 6 para. 1 f) GDPR for reasons arising from your particular situation. Your personal data will then no longer be processed for these purposes, unless compelling legitimate interests for the processing can be demonstrated that outweigh your interests, rights and freedoms, or the processing serves to assert, exercise, or defense of legal claims.

Right of complaint to the supervisory authority: You have the right to file a complaint with a data protection supervisory authority, in particular in the Member State of your habitual residence, place of work or place of the alleged infringement, if you consider that the processing of personal data concerning you is unlawful.
